

Altamont Landfill & Resource Recovery Facility

Basic Permit Provisions - Through 12/31/2005

- 1.) The LF can accept Non-franchised solid wastes (other than sludges, inerts and special wastes) for disposal from Alameda and SF Counties only, except as provided below for self-haul from Contra Costa.
- 2.) The LF can accept Franchised solid wastes (other than sludges, inerts, and special wastes) for disposal from only Alameda and SF Counties and from the City of San Ramon.
- 3.) The LF cannot accept any solid wastes (other than sludges, inerts and special wastes) for disposal from any other County other than Alameda and SF except as allowed in the table below (Contra Costa County).
- 4.) Limits for Sludges, Inerts and Special Waste for disposal are illustrated in the table below.
- 5.) There are no specific tonnage or origin limits on non-disposal tonnage such as ADC, reuse, recycle, or transfer materials.
